



MEDIA RELEASE FOR MINOR

In consideration of the participation in our Hip Hop is Green eXpo event _____ (name of minor), and for other good and valuable consideration herein acknowledged as received, upon the terms hereinafter stated, I and the minor hereby grant to Hip Hop is Green (HHIG) and any of their respective licensees, assigns, parents, subsidiaries, divisions, business units or affiliated entities and each of their respective employs, agents officers and directors (collectively “releases”) of my voice, actions, likeness, name , appearance and biographical materials (collectively “Likeness”) in any and all media now know or hereafter devised, throughout the universe, in perpetuity, in or in connection with Hip Hop is Green, the Hip Hop is Green Dinner, the 10th Element of Hip Hop Health & Wellness Symposium, the 10th Element of Hip Hop Health & Wellness Concert, the 10th Element of Hip Hop Health & Wellness Program , the Hip Hop is Green eXpo or any program associated with Hip Hop is Green and its affiliated entities.

I and the minor hereby grant to HHIG the irrevocable right and permission, throughout the world, in connection with the photographs he has taken of the minor, or in which the minor may be included with others, the following: (a) the right to use and reuse, in any manner at all, said media likenesses, in whole or in part, modified or altered, either by themselves or in conjunction with other media, in any medium or form of distribution, and for any purposes whatsoever, including, without limitation, all promotional and advertising uses, and other trade purposes, as well as using the minor’s name in connection therewith, if he so desires; and (b) the right to copyright said media likenesses in his own name or in any other name that he may select.

I and the minor further release and discharge HHIG, or others for whom he is acting, from any claims for remuneration associated with any form of damage, foreseen or unforeseen, associated with the proper commercial or artistic use of these images unless it can be shown that said reproduction was maliciously caused, produced and published for the sole purpose of subjecting me to conspicuous ridicule, scandal, reproach, scorn and indignity. I hereby waive any right that I or the minor may have to inspect and approve the finished product or copy that may be used in connection with an image that HHIG has taken of me, or the use to which it may be applied.

This authorization and release shall also inure to the benefit of the heirs, legal representatives, successors, and all persons or corporations acting with the permission of HHIG, as well as the party(s) for whom the media likenesses were created.
